- The National Board for Safeguarding Children have introduced the new Safeguarding Children Policy and Standards for the Catholic Church in Ireland 2016, which has been adopted by every Diocese, Religious Congregation and Religious Order in Ireland. This Policy replaces the current Diocesan Safeguarding Policy. A copy will be sent out to every parish and it is hoped that in the next few months it will be available on our website.
- It is nearly that time of year for the Parish Audits. Towards the end of April you will receive your Parish Audit. We ask that it is returned by the 20<sup>th</sup> May 2016. As we did last year, 6-8 parishes will be picked randomly to be visited by a member of the Safeguarding Committee to complete an onsite audit as part of the auditing possess. The Safeguarding Committee will be holding 2 evenings on Wednesday 27<sup>th</sup> April in Nenagh Pastoral Centre and Thursday 28<sup>th</sup> April in Ennis Pastoral Centre (full details to follow later) where you can come and return or ask any questions relating to the Audit.
- May is a dedicated month to Safeguarding in the Diocese. We will be sending out some words to go into the Parish newsletters for that month.
- Due to the new Garda Vetting Legislation coming on line in April, any outstanding vetting forms must be sent to myself by the 9<sup>th</sup> April 2016. After this date the current vetting forms will not be accepted for processing by the Garda Central Vetting Unit. On 29<sup>th</sup> April 2016, a new Garda Vetting form will be issued by the Gardaí and will be available on the Diocesan Website. An up to date list of those who have been garda vetted over last 3 years and those who are due to be revetted will be sent out to the Parishes with a batch of new garda vetting forms. \*Please destroy all current Garda Vetting forms that you currently hold.
